

REFINERY29 MAD CHATTER PRIZE DRAW TERMS AND CONDITIONS

1) The Prize Draw is open to residents of the United Kingdom, Channel Islands and Isle of Man, who are aged 18 years or over, except employees of Refinery 29 Limited ("Promoter") and Administrator (defined below) or their affiliated companies, their families, cohabitants, agents or anyone professionally connected with the Prize Draw. Proof of age will be required before the Prize is dispatched.

2) No purchase is necessary for entry into the Prize Draw. Entries received after the relevant closing date will not be accepted.
